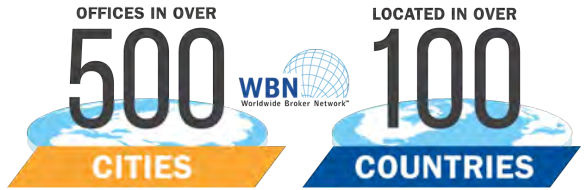

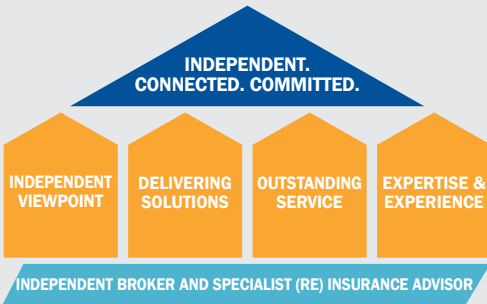

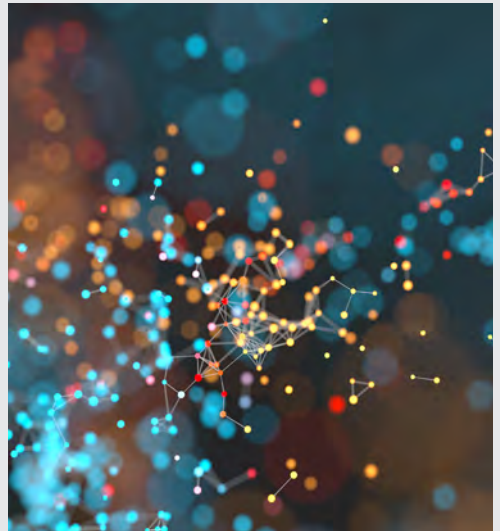
All types of reinsurance are catered for, whether on a traditional or structured basis.
